## Special and/or sensitive personal data that we process

## How long we keep personal details

Van Os Imports B.V. does not keep your personal data any longer than strictly necessary to realize the goals for which your data is collected. ## Sharing personal details with third parties

Van Os Imports B.V. shares your personal data with various third parties as necessary for the execution of the agreement and to meet a possible legal obligation. We conclude a processing agreement with companies that process your data on our behalf to ensure the same level of security and confidentiality of your data. Van Os Imports B.V. remains responsible for this processing. Social Road also provides your personal data to other third parties. We only do so with your explicit permission.

## Cookies, or similar techniques, we use

Van Os Imports B.V. uses functional, analytical and tracking cookies. A cookie is a small text file that will be saved in the browser of your computer, tablet or smartphone when you visit this website for the first time. Van Os Imports B.V. uses cookies with a purely technical functionality. These ensure that the website works properly and that, for example, your preferences are remembered. These cookies are also used to make the website work properly and to optimize it. In addition, we place cookies that track your surfing behaviour so that we can offer you tailor-made content and advertisements.

When you first visited our website, we already informed you about these cookies and asked your permission to place them.

You can unsubscribe from cookies by configuring your internet browser in such a way that it does not store any more cookies. In addition, you can delete all information that has previously been stored using your browser settings.

## Functional Cookies

## Analysis cookies

## Advertising, social and interest cookies

## Viewing, amending or deleting data

We will respond to your request as soon as possible, but within four weeks.
